	Driver Violations	Point of Sale MVR
	Exclude Drivers / Named insured	Any person but the named insured may be excluded
	Ownership	The registered owner or spouse can be insured
	Other Vehicles	All registered cars in the household must be insured
	Violations and surcharges	The chargeable history for each driver is 36 Months
	State Filing	SR-22 and SR-22A available
 VEHICLE	Registration	Must be the registered title owner
	Max Vehicles Per Policy	4 vehicles max per policy (any endorsed policies over 4 will be nonrenewed)
	Vehicle Size or Weight	Vehicles with carrying capacity up 3/4 ton
	Out of State Registration	No
	Ride Sharing	We do not accept ridesharing of any kind
	Altered Vehicles	We cover ONLY factory installed equipment
	Salvage Titles	We do not accept Salvage titles
 COVERAGE & FEES	BI/PD Limits	25/50/27,500 UM limits are the same / UMPD can be either 25,000 or 27,500
	Collision/Other Than Collision	Deductible options are 250, 500, 1000
	Towing	\$50 or \$75 reimbursement

 PAYMENT	Policy Reinstatements	Yes within 15 days with statement of no loss, late and reinstatement fee
	Down Payment Options	Full Pay / 16% down with 4-5 pay / 20% down with 4-5 pay / 25% down with 4-5 pay

 U/W	Required Documentation	Signed application to be maintained in the producers office for audit and legal
